Dear Family,

As the pandemic crisis began the Trustees decided to give a grace period on dues for all anniversary dates falling during April, May, and June. No member is being dropped during this time. All members will have until September 7th to pay their dues. Recently the trustees reviewed this concern again. Our organization has only two sources of income. One is individual and commercial member dues and the other is our national rallies. We do not receive grants nor funding from corporations or foundations. Except for two part time employees the leadership of FCRV comes from volunteers. Your camping family is also a business that has ongoing expenses. We maintain a website to assist you in understanding our programs and ongoing activities. Insurance still had to be paid. Office expenses and employee payroll still must be met. All of this comes at a cost. The trustees share your disappointment in all the cancellations of campouts. Those cancellations involved our two national rallies which provide revenue to

help keep dues lower and pay our ongoing expenses. Dues were last changed in 2016 and set at \$35 and \$45 CDN. The organization does have reserves to use at times like these. However, we have over the past 10 years consistently tapped those reserves at the average rate of \$30,000 per year. The Trustees reviewed the dues and decided it is not fiscally responsible to do anything at this time. We realize there might be people who have suffered substantially during the Covid crisis. FCRV does have a provision to help members affected negatively by disaster. Please contact any one of the Trustees if you are in need of assistance.

The trustees hope you will take advantage of the virtual campvention which was put together to provide connection among our family of campers.


Campvention activities will be held during the original campvention dates of July 13 - 17, 2020. Below are directions on how to connect to the activities and a schedule of the activities.

Preparing to Join Zoom Meetings

There are very good instructions and a video on the Zoom Support website that will provide you with the best introduction but we have tried to summarize here. For more details go to https://support.zoom.us/hc/en-us/articles/201362193

You can join Zoom meetings from your desktop, laptop, smart phone, or tablet.

A software installation will be required so before the day of the event, visit zoom.us/test to "join" a test meeting.



If joining from a desktop or laptop for the first time, you will be prompted to install the Zoom Client. Follow the prompts to complete the install. If you have previously installed the client but haven't used it since the software's last update, you will be prompted to install the latest version. Follow the prompts to complete that.

If you are joining from your smart phone or tablet, go to your app store and download the Zoom Cloud Meetings App PRIOR to joining the test meeting.



Expirations Dates

As things begin to open up and everyone starts to have gathering such as picnic and campout once again, have you ever wondered why there are so many dates on "food" packages? Do you truly understand what they mean? Which one is which and should I be concerned? All of the these questions will be addressed and clarified so that you can fully understand the difference between "best before", "use by", "open dating", "sell by/display until" dating.

"Ninety percent of American misinterpret the dates on labels according to a recent study from the Natural Resources Defense Council (NRDC) and throw out food that could still be consumed or frozen for later use." (1) People throw out large quantiles of food every day because a "date" is on the product and we do not know exactly what it means. In general, most individuals feel that a date on a product is the spoilage date and once this date has passed, it is to be tossed. This is false information. "According to the Federal Government product, dating is not required by their regulations. Under the jurisdiction of the Food Safety and Inspection Services, (FSIS) for example: meat, poultry, and egg products dates may be voluntarily applied provided they are labeled in a manner that is truthful and not misleading in compliance with their regulations." (5)

"In the United States, the Food and Drug Administration notes "a principle of U.S. food law it that foods in U.S. commerce must be wholesome and fit for consumption. However, the agency also states:

With the exception of infant formula, the laws that the Food and Drug Administration (FDA) Administer do not preclude the sale of food that is past the expiration date indicated on the label. FDA does not require food firms to place "expired by", "use by" or "best before" dates on food products. This information is entirely at the discretion of the manufacturer." (Wikipedia.org/wiki/Expiration date)

The United States Department of Agriculture makes the following clarification when it comes to product dating. Dates printed on the foods indicate when items will no longer be at their peak quality. Dates are not for safety, exception baby formula. In Canada, according the Canadian Food Inspections Agency (CFIA) an expiration date on food differs from a best-before date. Thus, the misconception-many individuals believe the date on various "food" is the spoilage date. This is not true. "In Canada expiration dates must be used on the following food items: formulated liquid diets, foods represented for use in very low-energy diets. Meal replacements, nutritional supplements, and human milk substitutes (infant formula.)" (6)

Are you totally confused at this point? Just for some clarification, there is some differences on package dating in the U.S. and Canada has a slightly different distinction. Therefore, here are some general guideline that are very similar for both countries. Well, some simple explanations will help to simply the process. Here is a simple out line as to what each possible "dates" means and what you should or should not do when it comes to keeping or throwing out that "food" item.

If you see "best if used by /before" on a food product, this provides you with the best quality date or flavor for this given product. It is still good beyond the date on the package or can. The date is strictly a "freshness" date meaning that the product is still good and edible long past the date on the package. For example a cracker may be "stale" and has lost its crispness but it is still safe to eat.

The <u>sell by</u> date, is a date set by the producer of the product and it tells retailers when to remove the product from the store shelves. Buy the product before this date. It is safe to consume after this listed date. The basic goal here is for the consumer that the product it at its best quality which can last a long time depending on the product. As an example: milk, will last five to seven days past it sell-by-date before spoiling as long as it has been kept in the refrigerator.

The "use by" date on the product's package indicates the last date the manufacture can offer and guarantees total freshness. This is the last date recommended for the best flavor or quality of the product. The only safety date mandated by the Federal Government is the expiration dates on the various varieties of infant formula. This is true in Canada as well.

Canned goods for example: canned fish, tuna, soups, and fruits and vegetables can be stored for two to five years in a cool place. Food with a high acid content such as canned juices, tomatoes and pickles can be stored for a year up to 18 months according to the USDA. If a can has a bulge on the top, bottom or sides, throw it out. A dented can that does not bulge is safe to consume. Non-perishable items such as cereal, grains and dried canned goods are useable past the date on the product. Fresh foods such as meats, dairy products and eggs are a very different story. These "food" items have a much shorter life span before they become unsafe to eat. Perishable foods held at unsafe temperatures can cause illness regardless of the package date indicated. Remember the general rule of thumb that; cold foods are to be kept refrigerated at all time.

Doctor Sana Mujahid, PHD, manager of food-safety research at Consumer Reports, states: "the best way to know whether a perishable food has spoiled is to simply trust your taste buds and sense of smell." (1) If it smells bad, or simply tastes bad, and you are in doubt, simply throw it out. Food products will tell you if they have passed their prime, mold, bacteria, and yeast have developed displaying warning signs to your senses. A food product that has spoiled looks funny, smell awful, the texture has changed, and color all give indications of spoilage.

It is essential that you understand why dates are on various food products. So many people see dates on a product that has transpired and believe the product is unsafe to consume. People waste a lot of food because they do not understand the various aspects of product dating. Complicated, true, dates on food products are miss leading. With the exception of baby formula, dates on consumable products are there for freshness and quality not spoilage consideration and it is to be taken under advisement. The more you know the better you become an educated consumer. Happy Shopping.

California Poison Control Offers Tips about Spider Bites

Poison San Francisco – June 15, 2020 - California Control System (CPCS suggests being on the

lookout for spiders which are increasingly active when temperatures rise. With more people sheltering at home or just starting to hike in the hills, the risk of bites is more likely. Spider bites can result in small puncture wounds, pain, redness, itching and swelling that can last a couple of days. Most bites are usually not serious. California Poison Control System received 2,500 calls related to insect and spider bites in 2019.

"Only a few spider species have fangs which can penetrate human skin and be worrisome to people. By following some precautions, people can minimize the chance of being bitten," says Dr. Rais Vohra, Medical Director for the Fresno/Madera Division of CPCS. He added that, most spiders are killed only because they scare people, not because they are actually dangerous to humans. Spiders generally prefer to live in undisturbed areas where they can catch insects in peace.

Black widow spiders are very common in California, while the brown recluse spider is not a cause of human injury in the state. The black widow venom is dangerous even when baby spiders



hatch. Black widows establish non-symmetrical webs in garages, closets, corners of patio furniture, as well as outdoors. They are usually not aggressive, so most bites occur because a spider is trapped or unintentionally touched. Dr. Vohra suggests the following spider bite prevention tips:

- Keep cribs and beds as far from the wall as possible.
- Shake all clothes thoroughly before wearing them
- Check your bed thoroughly before climbing in; more so if the bed has not been slept in for a while
- Always put on gloves and long-sleeved shirts when going through or emptying closets, boxes or containers that have sat undisturbed for a while.
- Turn your shoes over and shake them out before putting them on.
- Teach children to respect spiders and to find an adult if they see one.

The symptoms of a black widow spider bite include minimal redness at the bite site, and gradually increasing pain over several hours after envenomation (venom is injected). Dr. Vohra added that the biggest problem with black widow spiders is that the bites are exceedingly painful. Patients usually describe an unrelenting, throbbing, dull pain near the site of the bite. In severe cases, the pain can become generalized and affect the whole back, torso or abdomen. A bite on the hand or arm can cause chest pain, and bites to the lower extremities can cause abdominal pain. A small area of redness or a localized sweat patch at the site of the bite is a tell-tale sign that doctors look for. If pain is increasingly severe, seek medical attention, as effective medicines are available.

Not all black widow bites need medical attention. Reasons to go to the doctor after a spider bite include discomfort which is increasingly severe; spreading local redness accompanied by pain and any drainage from a bite site.

People who believe that they have been bitten by a spider is far more common than actual spider bites, and many "bites" are actually bacterial skin infections. An expanding red painful area on the skin may be a staph infection and should be examined by a physician.

It should be noted that tarantulas, whether native or exotic, can also cause injury either with a bite or the irritation from their many hairs when they enter the skin or eyes.

SURGE: 'BIG INFLUX OF PEOPLE WHO'VE NEVER DONE THIS BEFORE'

EDITOR'S NOTE: Showing no signs of letting up, reports continue to surface of the surging consumer demand for RVs.

New Hampshire outdoors and campgrounds are always a destination for tourists, but some sectors of that industry are starting to see an uptick in business and interest during the pandemic, according to <u>a report today</u> (June 22) by WMUR.

It was a difficult few months for any industry, including places like RV dealerships. But, sales are starting to turn around at <u>Camping World in Chichester</u>, N.H., as people look to get outside and take their families on vacation. "We were off by probably 60%. Now, we've seen a boomerang the other way and we're getting new buyers more than anything," General Manger of Camping World Tony DiBenedetto said.

DiBenedetto said they made do during the pandemic by going virtual and delivering some RV's to people's homes. But lately, he has seen a new kind of customer. "We're seeing a big influx of people who have never done this before. So, it's kind of cool for us to kind of get all the newcomers in there. There's a lot of questions," he said.

• Right now, RV sales are through the roof, <u>local RV retailers told WDBJ</u>. Those dealers say while the pandemic is driving people to the great outdoors, it's also left them scrambling to meet the demand. That includes the staff at <u>American Family RV</u> in Salem, Va., meeting more American families than ever before.

"Nobody wants to fly or go on a cruise. Camping is social distancing at its best," said owner Layne Rowland. He said since March, work has been steady, and then some. "It's been incredibly busy," he said.

Not only on the lot, but even online. General Manager Kevin Thomas said their website is getting three times the traffic they had pre-pandemic. "Our website has seen an increase so heavy that we've had to increase our package that was available to be able to accommodate everybody," said Thomas.

• Families are taking titans of travel and making them king of the road. Travelers, vacationers and wanderers everywhere are trading in their Boeing 737 seats for the comfy couches and flat-screen TVs inside RVs, fifth-wheelers and travel trailers.

"That tells me they're not going to Disneyland," Tom Schaeffer, owner of <u>Tom Schaeffer's RV Superstore</u> in Perry Township, Pa., <u>told WFMZ</u>.

Schaeffer said he's having a record sales year, made up of a lot of first-time buyers and families. "These new buyers have never had one, and they just want to get out," said Schaeffer Sure, they're selling a record number of units, but Schaeffer said his dealership could run out of inventory on some of its most popular models as early as next month. That, along with lengthy pre-delivery inspections before every sale, at times it stretches them thin. "It gets to be a chore, let me tell you, when you're hit with so many orders," said Schaeffer.

• The RV industry is booming and the demand is starting to outweigh the supply, according to <u>a report by Spectrum News 1.</u>

"Manufacturers shut down for about a month and a half which put about 20,000 units that aren't on dealers' lots, so inventory is getting hard to find," said Jennifer Radel, president, <u>All Seasons RV</u> in Streetsboro, Ohio. Radel said her RV lot is only about half-full. That's because sales are soaring. "It was pretty quiet for the first month and a half, but first of May everybody was kind of tired of being cooped up and have decided that RVing is a super safe way to travel, you don't have to worry about airports or hotels, so our business has just skyrocketed," said Radel.

FIFTH-WHEEL MARKET ADDING TECHNOLOGY, SQUARE-FOOTAGE

While travel trailers are still king of the market when it comes to annual RV sales, fifth-wheels command a significant – and growing – audience of devoted RVers.



OEMs are offering inviting floorplans with defined living spaces, innovative amenities, plenty of technology and lots of cargo storage. Those features, along with what many describe as an easier hookup and towing experience, makes the fiver of today an attractive option. what many describe as an easier hookup and towing experience, makes the fiver of today an attractive option.

And with a relaxing of fifth-wheel square footage limitations by the Recreational Vehicle Association of America

(RVIA), the floorplans have the potential to become even more spacious.


"I think that's the biggest thing that's happening right now, especially in the large fifth-wheels," said Nate Goldenberg, general manager of the Solitude fifth-wheel and Momentum toy hauler lines at Grand Design RV, a subsidiary of Winnebago Industries.

In March, the RVIA Board of Directors approved the removal of a board-mandated 430 square feet limitation in set-up mode for fifth-wheels. The decision was the result of a U.S. Housing and Urban Development ruling that RVs are not housing – a ruling based on findings from a cross-collaboration task force established during a previous RVIA board meeting.

"Now we can build bigger. And it doesn't necessarily mean longer, but you can make slides deeper. You can add slides," Goldenberg said. "It just gives us so much more versatility from a floorplan perspective." With regard to technology, Grand Design launched solar-equipped offerings in September, which have done well, he added. "In that area, I think some safety items, like cameras and tire pressure monitoring systems, are the most popular. We're hearing more and more about that," Goldenberg said. "But from an OEM perspective, a lot of times it's hard to spend money in those areas when customers can pick the best fit for them in the aftermarket."

While the typical customer for a fifth-wheel is generally a more experienced camper, Goldenberg is seeing that, "As an industry right now – especially with the COVID pandemic – there's an increase in all new buyers in all demographics."

He said Millennial buyers are trending more toward travel trailers but when today's new buyers determine how much storage and space they need, what works best for their family and what they're comfortable towing, some will naturally migrate to fifth-wheels.





"The RV industry on the whole is on a boom," said John Stringer, general manager for Forest River who oversees the Flagstaff and Rockwood sister lines of fivers and travel trailers. "And there's a natural migration of people toward fifth-wheels as they want to travel more."

He said one segment of the market wants to camp in place for a longer period of time, pointing out that that's really leaning toward the travel trailer buyer. But these days Stringer said he's seeing more people who want to travel more frequently – every day, every other day or every third day.

"That's the person who's migrating toward the fifth-wheel," he said.

And as those buyers edge up the percentage of fivers on the road each year, Forest River is poised to offer eight new floorplans to broaden that market.

Another trend Stringer has noticed is that the fifth-wheel, primarily known a couple's coach, is now attracting more families.

"It's becoming much more of a family coach – friends and family – things like that," he said.

These buyers are seeking more options, which has led Forest River to offer solar panels and other technology aimed at off-grid camping, as well tire pressure monitoring systems and Wi-Fi connectivity as standard equipment – all geared toward people who are spending more time on the road and in their coach.

"Where we've been most aggressive with Rockwood/Flagstaff is trying to come up with innovations," he said.


